Notification of Donor Intent

Regardless of the method chosen to deliver a gift of stock, the donor or the transferring broker must provide the following information, for audit and acknowledgement purposes:

- * Donor's name and complete address
- * Name and number of securities transferred
- * Broker's name and phone number
- * Approximate dollar value of gift
